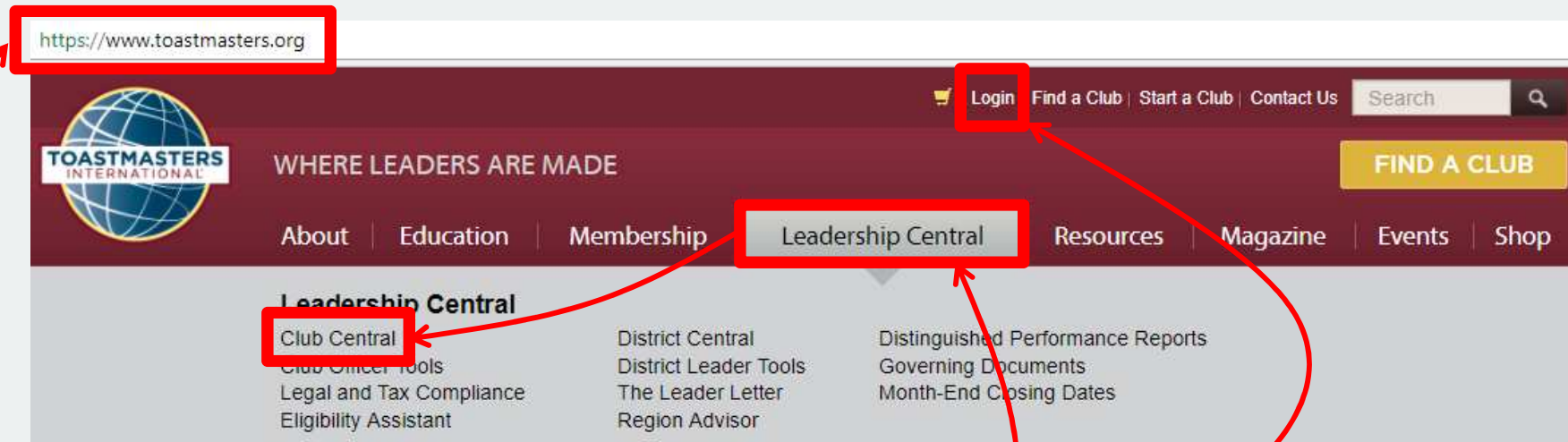




ASSIGNING PROXY

**How to assign proxy for
Annual Business Meeting
at the International
Convention (IC)**

First, go to your Club Central



1. Go to toastmasters.org
2. Log on
3. Go to your Club Central
4. Select club for which you want to assign proxy

Note: you can only assign proxy for your club if you are Club President or Secretary. Either of you assign both votes for the club, so no need for the other one to assign proxy separately.



When you are in Club Central select: Club Proxy

When you are eligible to assign proxy for International Convention, this option will appear first, in top left corner of your Club Central.

1. If someone from your club will attend IC and you want them to take your club's vote, choose this option.

2. If (1) is not the case, you may assign your proxy to your District Director...

3. ...or, if you know any other Toastmaster who will attend IC and you would like to pass your club's proxy to, select this option.

You must notify the proxyholder that you have selected him or her to carry your club's proxy, which he or she may access via "My Profile" on the Toastmasters website.

Click here and from the list select the club member who's going to IC and can take your club's proxy



If you select District Director, no further selections are required
